It is informed that, while enclosing the list of appointed by transfer AEEs and A.Es in the reference 2nd cited, it was requested to furnish the degree / diploma certificates on or before 27-12-2017.

In this regard, it is informed that certain circle / unit officers (listed in the statements) have not furnished the diploma / degree certificates even after 3 months. It was informed in the circular memo that in order to compliance the Hon'ble Supereme Court Orders dated: 03-11-2017, verification of the certificates furnished by the AEEs and A.Es at the time of their appointment is required. Inspite of clear instructions issued in the reference 2nd cited, in view of Hon'ble Supreme Court orders, the matter has been dragged for more than 3 months, which is viewed with much displeasure.

In view of this, and in order to avoid further delay in this process, the circle / unit officers as listed in the annexure enclosed, are hereby once again requested to obtain the attested copies of degree / diploma certificates (**duly verifying the original certificates at their end**) from the AEEs and A.Es and furnish the certificates as per the statement enclosed in full shape immediately on or before 30-04-2018 without fail.

It is clearly informed that no further reminders will be issued in this matter, and the lapse in furnishing the above information from any Unit may lead to disciplinary action as per rules in force.
