In continuation of this office proceedings 4<sup>th</sup> read above, and under Rule – 10 (a) of T.S. State and Subordinate Service Rules, 1996 and subject to the condition laid down in General Rule 10 (c) and (e) of T.S. State and Subordinate Service Rules of 1996, the Assistant Technical Officers, listed in the Annexures I&II enclosed to this proceedings are hereby promoted on Adhoc basis as Technical Officer in the time scale of pay of Rs. 31460-880-33220-950-36070-1030-39160-1110-42490-1190-46060-1270-49870-1360-53950-1460-58330-1560-63010-1660-67990-1760-73270-1880-78910-2020-84970 and posted as Technical Officer to the office shown against their names.

2. The promotion ordered in Para – 1 above is purely temporary and subject to review/revision at anytime without any notice and without assigning any reasons thereof. The Adhoc promotions are also subject to the final outcome of the court cases pending at Hon'ble High Court of Telangana, Hyderabad. Their Adhoc Promotions as Technical Officers does not confer any right what so ever for claiming regular promotions as Technical Officer.

3. As per Sub-Rule (b) of Rule – 11 of T.S. State and Subordinate Service Rules, 1996, substituted in G.O. Ms. No. 145, G.A. (Ser. D) Department, Dated 15.06.2004 he / she shall join duty in the post of Technical Officer immediately from the date of issue of this order. If he / she fails to join duty / evades / proceeding on leave in the new post of Technical Officer within the stipulated period of 15 days, he / she shall forego the promotion right / offer for a period of One year and his / her name shall be considered for promotion again after a period of one year from the date of offer of the promotion, subject to availability of vacancy and eligibility.

4. As per Para – 4 of Govt. Circular Memo. No. 216 – A/A2/PC-II/2007-1, Fin. PC – II Deptt., Dated 23.03.2007, in case the individual refuses promotion as Technical Officer by not joining in the place posted, Automatic Advancement Scheme will not be made applicable to him / her in future.
