Government have taken up a Programme “**Mission Kakatiya**” as a part of restoration of Minor Irrigation Tanks in Telangana. The programme is proposed to be completed in a phased manner in 5 years period. Out of 46531 tanks available in Telangana, about 9306 tanks are proposed to be taken up in first phase during this year.

The Government vide reference 1st cited have accorded permission to engage the Services of 115 Retired Deputy Executive Engineers/ Assistant Executive Engineers/Assistant Engineers/Technical Officers for a period of One year to meet the work load of Minor and Medium Irrigation works, subject to the following conditions.

- i) Consolidated remuneration shall be Rs.25,000/- per Month.
- ii) The Employees retired without any disciplinary cases / charges pending against them only be considered for the above contractual assignment.

iii) The retired Engineers who have not crossed the age of (65) years shall only be considered as the retired Engineers have to work mostly in the field level for restoration of Tank works.

Accordingly orders were issued for engaging services of 98 retired engineers for Minor and Medium Irrigation works vide this office proceedings 3rd, 5th, 7th, 9th and 11th, 13th and 15th cited.

The Chief Engineer, Minor Irrigation vide reference 16th cited has submitted the proposals of 2 more retired DEEs/AE's for engaging the Services on contract basis for a period of one year .

After examining the proposals of the Chief engineer, Minor Irrigation, Orders are hereby issued engaging the services of 2 no of retired DEEs/AE's as per Annexure in addition to the proceeding communicated vide reference 15th cited, for the period of one year from the date mentioned against their names indicated in the Annexure. Circle/Unit allotted is also indicated in the Annexure.

The concerned Superintending Engineers/Unit Officers are requested to download the proceedings from the Official Website (www.irrigation.telangana.gov.in) and communicate to the individuals.


The Superintending Engineers /Unit officers are requested to issue re-allotment orders to the individuals indicating the place of work i.e Circle/Division/Sub-Division/Section.
